

DEFERRED DISPOSITION (DD) / PROBATION APPLICATION

(REQUEST MUST BE RECEIVED ON OR BEFORE YOUR APPEARANCE DATE)

YOU MAY BE ELIGIBLE FOR DEFERRED DISPOSITION IF:

1. You did **NOT** hold a commercial driver's license (CDL) at the time of the offense;
2. Your offense was **NOT** issued in a construction zone with workers present.

IF YOU ARE ELIGIBLE, YOU ARE REQUIRED TO COMPLETE THE FOLLOWING IN PERSON OR BY MAIL ONLY:

1. Age twenty-four (24) and younger with a **REGULAR** license must complete a Driving Safety Course (DSC) in addition to Deferred Disposition; however, no Driver Record or Driving Safety Course Application is required.
2. Age twenty-four (24) and younger with a **PROVISIONAL** license must complete **BOTH** a Driving Safety Course (DSC) and be examined by the Texas Department of Public Safety in addition to Deferred Disposition; however, no Driver Record or Driving Safety Course Application is required. A \$10 fee does apply for the examination.
3. Payment of the full bond amount;
4. Present the Deferred Disposition Request section below.
5. Present the Deferred Disposition Affidavit section below.
