

**DRIVING SAFETY COURSE (DSC) APPLICATION**  
**(REQUEST MUST BE RECEIVED ON OR BEFORE YOUR APPEARANCE DATE)**

**APPLIES TO THE FOLLOWING TRAFFIC OFFENSES:**

1. Obeying Warning Signs, Section 472.022 TC
2. Rules of the Road, Subtitle C, Title 7, Sections 541-600, TC
3. Operation of Motor Vehicle- Minors, Section 729.001(a) (3), TC

**YOU MAY BE ELIGIBLE FOR A DRIVER SAFETY COURSE IF:**

1. You have a valid Texas Driver's License or permit (out-of-state military license acceptable with signed DSC affidavit);
2. You have evidence of liability insurance card or other evidence of financial responsibility on yourself not vehicle;
3. You have **NOT** taken a Driver Safety Course within the last twelve (12) months preceding the date of the offense (military, not in another state);
4. You did **NOT** hold a commercial driver's license (CDL) at the time of the offense, Article 45.0511(s), CCP;
5. Your offense was **NOT** one of the following:
  - a. Speeding in excess of 25 miles per hour or more over the regular speed limit or 15 miles per hour or more over the speed limit in a school zone, Article 45.0511(b)(5), CCP;
  - b. Issued in a construction zone with workers present, Section 472.222, TC; Article 45.0511(p)(3), CCP;
  - c. Passing a school bus loading or unloading children, Section 545.066, TC;
  - d. Leaving the scene of an accident, Sections 550.022 or 550.023, TC;
  - e. Accident involving damage to vehicle, Section 550.022, TC;
  - f. Duty to give information and render aid, Section 550.023, TC.

**IF YOU ARE ELIGIBLE, YOU ARE REQUIRED TO COMPLETE THE FOLLOWING IN PERSON OR BY MAIL ONLY:**

1. **Payment of either \$109.00 if **NOT** in a school zone or \$134 if in a school zone (includes \$10 administrative fee).**
2. Present a copy of your valid Texas Driver's License or permit.
3. Present a copy of your liability insurance card or other evidence of financial responsibility;
4. Present the Driver Safety Request section below.
5. Present the Driver Safety Affidavit section below.
